## MAINTENANCE WORKER I

Great opportunity for a self-motivated individual with a commitment to quality and customer service to join our respected team of professionals. Under supervision, performs a variety of building maintenance work including but not limited to plumbing, electrical, mechanical, appliance and structural repair.

*Key responsibilities include but are not limited to:* 

- Perform a variety of interior and exterior building maintenance work and specialty systems repair or
  construction including work involving plumbing, electrical, mechanical, structural, heating, carpentry, concrete
  and major appliance repair; assists in rehabilitation work on vacated units including but not limited to cleaning
  of fixtures, appliances, walls, windows and floors and the repair and replacement of hardware, paint, cabinets,
  counter tops and assorted other carpentry duties.
- Properly document work.
- Safely drive a variety of vans and trucks and use building maintenance and construction hand and power tools. Utilize proper safety precautions related to all work performed.
- Perform manual labor tasks as necessary.
- Interact with colleagues, clients, and Agency contacts in a professional, tactful and courteous manner, ensuring excellent customer service is delivered.

The successful candidate will possess the following qualifications and personal attributes:

- Knowledge of plumbing, electrical, and mechanical systems in residential buildings;
- Knowledge of the care and use of building maintenance hand and power tools;
- Cleaning methods and custodial procedures;
- Good verbal communication and customer service skills;
- Ability to utilize smartphone/tablets for processing work orders;
- Ability to frequently lift/carry objects weighing up to 50lbs and occasionally weighing up to 100 lbs;
- Valid California driver's license and DMV driving record in good standing that meets HACSB's insurability requirements is required; and
- Bilingual with Spanish (desirable).

#### **SELECTION PROCESS**

For primary consideration, applications and supplemental questionnaires must be received no later than **Monday, May 22, 2017 at 5:30PM**; thereafter position open until filled. Selection process may include an interview and other testing designed to predict successful job performance.

If HACSB determines an applicant is suitable for the position based on a job related evaluation of skills and experience, prior to final selection and subsequent employment, applicant will be subject to a criminal background check, appropriate to the job functions and business necessity. Criminal convictions will not automatically disqualify a candidate for employment. The nature of the crime, time since offense, surrounding circumstances, and relevance of offense to position applied will be considered. Appointments are contingent upon successful completion of a post-offer medical exam.
